We are also encouraging all dog owners to do an inspection of their properties to ensure that their dog does not escape from their property. All dogs living within the Town of Redwater must have a license as set out in our Dog Bylaw. As long as your dog is licensed and is wearing the tag, they are identifiable. Please ensure that information provided to the office when purchasing a license is current and that your dog is wearing the license. Any dog found at large may be subject to a fine and impound fees and must be paid prior to your dog's release.

## Community Business License Fees

Business License Bylaw 891, passed by Council at the February 2, 2021 Council Meeting, allows for Resident, Home Occupation and Youth Businesses operating in Redwater to have the applicable business license fees waived from *January 1, 2021- December 31, 2021*.

If your business is a Resident, Home Occupation or Youth Business operating in Redwater and has already renewed your 2021 business license, a refund cheque will be issued to your business.

If your business is a Resident, Home Occupation or Youth Business operating in Redwater and has not renewed your 2021 business license but had a business license in 2020, no payment will be required for your 2021 business license and a copy of your license will be mailed to you.

If your business no longer operates in Redwater please email [ecdev@redwater.ca](mailto:ecdev@redwater.ca) or call 780-942-3519 ext. 330 and your information will be updated in our system.

Please note that all 2021 Non-Resident and Temporary Business Licenses will still be required and charged at the applicable rate.
