COMMUNITY BUSINESS LICENSE FEES WAIVED IN 2021

Business License Bylaw 891, passed by Council at the February 2, 2021 Council Meeting, allows for Resident, Home Occupation and Youth Businesses operating in Redwater to have the applicable business license fees waived from *January 1, 2021-December 31, 2021*.

If your business is a Resident, Home Occupation or Youth Business operating in Redwater and has already renewed your 2021 business license, a refund cheque will be issued to your business.

If your business is a Resident, Home Occupation or Youth Business operating in Redwater and *has not* renewed your 2021 business license but had a business license in 2020, no payment will be required for your 2021 business license and a copy of your license will be mailed to you.

If your business no longer operates in Redwater please email ecdev@redwater.ca or call 780-942-3519 ext. 330 and your information will be updated in our system.

Please note that all 2021 Non-Resident and Temporary Business Licenses will still be required and charged at the applicable rate.
